The Person who will collect the Tender documents must furnish the copy of CNIC documents as mentioned at Para 2 (i to iv) and authorization letter issued by proprietor / Director of firm or Company letter head addressed to DCEEE(S&C) Tender Document will be issued on payment of Tender fee @ Rs 5,000/- either through Pay Order/Bank Draft in the favor of Chief Accounts Officer KPT or cash. Each (pay order or cash) to be deposited through Bank Chalan

2. All the Tender documents should be filled properly, signed, and stamped each paper. Each and every paper should be submitted along with the tender. Further following copies are also to be enclosed along with the tender documents which are mandatory without these copies the Tender will not be accepted

- Valid copies of NTN Certificate, GST Certificate and ATL showing active in fresh date
- Copy of registration certificate with PEC in Technical Category ME-04, ME-05, ME-06 and Financial Category C-4
- Registration Certificate of Sindh Revenue Board regarding Sindh Sales Tax on services
- Affidavit is to be submitted on Rs 100/- stamp paper mentioning therein that the firm has not been black listed by any Government/Semi Government / Autonomous / Semi Autonomous body

3. The bidding process shall be following in accordance with PPRA-2004 rule/clause 36(B) - a Single stage two envelope procedure. The name of work, and complete name of firm, Contact No & Address of firm/company shall be indicated on the sealed bidding envelope
